

Acceptance of Grant Application

Each children relief project receiving a grant award must provide the following over the one-year grant period:

1. A written response upon receipt of each monthly grant payment;
2. Each monthly response should provide us with a brief description of current activities and how the SladeChild Foundation grant support is being used;
3. Digital photographs (color or black/white) are requested to be e-mailed every quarter (every three months) per grant year for use in our newsletters, website, etc.
4. Any other conditions of the grant award.

Required Materials

NEW PROJECTS

1. Articles of Organization;
2. For U.S. projects: IRS 501(c)(3) determination letter;
3. Non-U.S. projects: Certificate of non-profit organization status from appropriate governmental agency;
4. Items 6 - 9 below.

RENEWING PROJECTS

5. Written statement certifying that the above items (1-3) previously submitted to the SladeChild Foundation have not been substantially modified or changed in any way;
6. A summary of the past year's events, e.g.: Annual Report, newsletters, year-end wrap-up, etc.
- 7a. For non-U.S. projects: Full financial statement for the immediate preceding year. A full financial statement includes all sources of income and revenue, and all expenses, outlays, liabilities, loans, commitments, etc. If your financial statement is in your country's currency, what is the exchange rate? _____
- b. For U.S. projects: You must submit IRS form 990 for the preceding year. If your project is exempt from this IRS requirement, explain why, and submit full financial statement as described in 7a above for non-U.S. projects.
8. Names of the project's chief financial officers, and all other individuals, including all signatory powers for bank accounts, having control over SladeChild Foundation grant monies;
9. Signed certificate (attached) verifying restricted application of SladeChild Foundation grant monies.
